Tuition charges are based on your registration. We encourage you to review the listing of 2017-2018 [tuition and fees](#), along with [refund policies](#), prior to registration. Included in your fees will be a non-refundable Registration Fee.

Bills for tuition will be available on June 15. An email notification will be sent alerting you that your bill is available in Self-Service. Paper statements will also be post-mailed to your current address. Payment will be due by July 15. For more information regarding [payment options](#) and [late payments](#), please visit our website.

Registrations not completed online by May 5, will need to be submitted manually to the Registrar's Office and will be subject to a Late Registration Fee of \$100. Registrations received after June 14 will be billed within 1-2 business days and payment will still be due July 15. After July 15 payment will be due at the time of registration.

Students receiving financial aid must have their financial aid fully approved prior to the billing deadline. Fully approved financial aid will appear as Anticipated Aid on your student account. If you have not already done so, you may still apply for financial aid by completing a [FAFSA](#) for the 2017-2018 academic year.

Students in the Master of Science in Interior Architecture program receiving federal financial aid must be enrolled in a minimum of 3 academic credits that apply towards their degree requirements in semesters where they are receiving federal aid. Failure to enroll in the minimum required credits will result in the cancellation of federal aid. Failure to attend or complete courses in which you are enrolled may result in the reduction or cancellation of your federal aid. Graduate students are awarded Direct Federal Loans to cover their tuition and anticipated fees. Students may be able to borrow additional funds for any direct costs or education related expenses.

Students who anticipate taking out private student loans are advised to apply for such loans as early as possible. Private student loans must be fully approved and certified by the school before they can be used for registration clearance.

TUITION REFUND INSURANCE

Tuition Refund Insurance is billed to all students with the option to waive each semester. Under this insurance policy if you are unable to complete the semester due to a covered medical reason, you may be eligible to receive a full refund of all of your tuition and fees even though the school's policy will no longer grant a refund.
