### **I-20 Process Guidelines**

If you require F1 visa sponsorship, let's move forward with the [international processes](#) required to secure your student visa. First, we need to process your BAC [I-20](#). To begin, please submit the following items to me by email:

1. [Certificate of Finance](#) (COF)
2. Bank Statement(s) and Bank Letter(s) (issued within the past 180 days; in English; any currency is accepted)
3. Copy of your passport

You can find examples of an acceptable bank statement and bank letter for reference within this packet. The financials shown must prove a minimum of the USD amount designated on the first page of the COF and further must:

- State that you or the sponsor is a member of the bank and the account type/number.
  - The BAC accepts liquid accounts, such as a checking or savings account, or accounts where the account holder has immediate access to their funds.
  - The BAC does not accept mortgage accounts, retirement accounts, real estate, jewelry, or other non-liquid assets.
- State your or your sponsors' current account balance as of that specific date.
- Designate the currency shown.
- Be signed/stamped by a bank representative.

To meet the required amount of finances, you may have more than one sponsor. If you do, please ensure each sponsor submits his or her own Affidavit of Support from the COF (page 3), as well as their own bank statement(s) and bank letter(s).

If you have [dependents](#) you are sponsoring on your I-20, please submit a copy of each dependent's passport in addition to the dependent section in the I-20. Please note that the COF will therefore require you to show additional funding.

If your sponsor will be providing financial support from a business account, then you must submit a recent bank statement from the business account, an official bank letter indicating the name of the individual(s) who have signatory power, and an affidavit of support for the individual(s) listed. travels to Boston.

In order to apply for an F-1 visa to study at the BAC, international students must receive the Certificate of Eligibility (I-20) from the BAC upon acceptance to the institution.

To obtain an I-20 form, a **Certification of Finance** must be completed and returned along with other application materials to the Admission Office. The form requires you to specify the amounts and sources of funds accompanied by a certified statement of sufficient financial resources verified by a bank or other financial institution. Verification of financial resources must be in the form of notarized documents of bank statements, scholarship awards, and loan approval.

The financial documentation must adequately cover a minimum of **one year's** amount of academic and living costs (please refer to the Estimate of Expenses list below). After carefully reviewing your financial documentation, the BAC will determine whether we can issue an I-20 for you. **Photocopies and/or scans of bank statements are accepted.**
